TO: Elena Reed, Town of Kenduskeag, in said County...

Greetings:

In the name of the State of Maine, you are hereby required to notify the inhabitants of the Town of Kenduskeag, County of Penobscot, qualified by law to vote in said Town's affairs, to assemble at the Town Office, in said Town of Kenduskeag on Thursday March 24, 2022 to vote by secret ballot, for the Election of Officers and consideration of articles 1 thru 2 of this Annual Town Meeting Warrant. Polls shall open at 10:00 am and close at 6:00 pm.

And to notify the voters to assemble at the Municipal Building in said Town of Kenduskeag at 7:00 pm on Friday, March 25, 2022, for the Annual Town Meeting, and then and there to act on articles 3 thru 35 of this warrant.

Article 1. To elect a Moderator to preside at said Annual Town Meeting.

Article 2. To elect by secret ballot, a Selectman for a three (3) year term, an Assessor for a three (3) year term, an Overseer of the Poor for a three (3) year term and a M.S.A.D. #64 Director for a three (3) year term.

Article 3. To elect two (2) Budget Advisory Committee Members for three (3) year terms.

Article 4. To see if the town will vote to elect one (1) Library Committee Member for a three (3) year term, one (1) for a two (2) year term and one (1) for a one (1) year term.

Article 5. To elect a Cemetery Sexton for a one (1) year term.

Article 6. To see if the Town will Raise and Appropriate \$102,850 for General Administration Salaries as follows:

Article 21. To see if the Town will vote to Raise and Appropriate \$75,000 for Insurance Services as follows:

Contingency Fund:	\$10,000

Article 22. To see if the Town will vote to increase the tax levy limit of \$215,502.15 established for the Town of Kenduskeag by State Law, in the event that the municipal budget approved under the preceding articles will result in a tax commitment that is greater than that property tax levy limit.

Article 23. To see if the Town will vote to fund Articles 6 through 22 of this warrant by Appropriating the follow amounts:

Informational notes: Refer to budget sheet.

Article 24. To see if the Town will vote to fix a date when taxes are due and payable, and to see if the Town will fix a rate of interest on taxes unpaid after said date. (Recommended: Taxes shall be due and payable on October 1, 2022, and that interest shall be charged at the rate of 4% per annum from October 2, 2022)

Article 25. To see if the Town will vote to accept donations by individuals and organizations to be used as specified.

Article 26. To see if the Town will vote to Raise and Appropriate from 2022 taxes to pay for tax abatements.

Article 27. To see if the Town will vote to authorize the Selectmen, on behalf of the Town, to sell or dispose of any real estate acquired by the Town for non-payment of taxes, and to execute Quit-Claim Deeds for said property. If the sale of said property is to persons other than the original owner or members of his/her family, the sale shall be by sealed bids, with prior notice given to the general public.

Article 28. To see if the Town will vote to accept grants from State and Federal Agencies, to be used as specified in the grants.

Article 29. To see if the Town will vote to authorize the Selectmen and Treasurer on behalf of the Town, to transfer monies from Trust & Reserve Funds to the General Fund, in anticipation of real estate taxes. To be returned on or before December 31, 2022.

Article 30. To see if the Town will authorize the Tax Collector to accept pre-payments of real estate taxes.

Article 31. To see if the Town will vote to authorize the Selectmen to spend an amount not to exceed 3/12 of the 2022 Annual Budget during the period from January 1, 2023 to the 2023 Annual Town Meeting.

Article 32. To see if the Town will vote to authorize the Board of Selectmen to sell, or otherwise dispose of, excess vehicles and equipment, and deposit any proceeds into the appropriate department's account.

Article 33. To see if the Town will vote to appropriate up to 144,165.58 of Coronavirus Local Fiscal Recovery Funds (a/k/a American Rescue Plan Act or "ARPA" funds) received by the Town from the federal government for qualified projects, as authorized by the Select Board; provided, however that the Select Board shall conduct a public hearing on the proposed expenditure of such ARPA prior to expenditure of the same.

Article 34. To see if the Town will vote to Appropriate up to \$5,000 from the Coronavirus Local Fiscal Recovery Funds for a website for the Town of Kenduskeag.

Article 35. To see if the Town will vote to accept any monies from State and Federal Grants to construct a new fire station.

The Registrar of Voters will hold office hours while the polls are open to correct any errors or change of name or address on the voting list, and to accept any new enrollments only. Any person who is not a registered voter may not vote in any election.

Greeting's,

As we enter 2022 we'd like to say thank you to our town's citizens and the selectboard for their support through the last year. Without the support of our local community members we wouldn't be able to do the job we do. We also want to thank our members for their continued dedication to serving our town and surrounding towns. They are our greatest asset to the department.

The members of the department are staying busy. Though the covid-19 pandemic has kept us on our toes for the past few years, members have been as active as possible in continuing our training and preparing for the wide variety of calls. We currently have 16 members ranging from new to experienced. Of our 16 members 5 are officers in the department and 6 are licensed EMT's. We will continue to focus on training this year and being as prepared as possible.

Some may be aware that last year we launched a pilot program for Monday-Friday night EMS staffing. This program guaranteed a first responder whenever one was available to be on duty from 6PM-6AM. Continuing this program will be voted on at town meeting this year and I encourage everyone to support this. We are currently exploring a mutual aid agreement with Levant to assist one another in staffing an ambulance overnight with this staff member and a member of Levant. If this staffing passes and the selectboard approves we will move forward to better cover our town at night when our risk is the greatest and population is the highest.

Our biggest challenge currently is manpower, not only in our community but the surrounding communities as well. We are not staffed 24 hours a day, meaning we are never sure a member will be available to respond. I encourage anyone interested and willing to volunteer to send an email to kenduskeagfirechief@gmail.com. We offer training that are paid for and quarterly stipends and pay.

Animal Control Report

To the Taxpayers & Pet Owners of Kenduskeag:

I am Gary Sudsbury Sr. from Dover-Foxcroft. Because of my concern (but mostly my love of animals!) I once again will assume the responsibility as the Animal Control Officer for Kenduskeag. Please feel free to contact me at 564-2931 or 343-4389. If you have a complaint or questions, I will do my best to answer them, or try to find the answer for you.

Please remember that as owners or keepers of cats & dogs, they must be vaccinated against rabies under Maine Statutes. You will need to show proof of up to date rabies shots in order for your town to issue a license for your dog(s). Dogs over 6 months of age must be licensed by January 1st by Maine State law. Please keep in mind that there is a late fee of \$25 per dog after January 31st.

In addition, any dog(s) that reaches the age of six months between January 1st. October 15, of any year must be vaccinated against rabies and be licensed within 10 business days.

If you no longer own a dog, or sadly they have died, please contact your town office so they can update their records.

Please believe me as an animal lover I can understand that when one finds a cat or dog or any animal that is sick or hurt, our first thought is to get it to a veterinarian for help; but in doing so you should understand that you could be held responsible for all expenses for the treatment and boarding of the injured animal. As an Animal Control Officer, it is my responsibility, under 7-3948 paragraph 2, to take an injured stray animal to the owner, if known, so the owner can seek the medical attention it may need. If the owner is unknown, under Maine law, I shall seek medical attention for the injured companion animal.

Please always be aware of the danger of rabies when approaching any domesticated or undomesticated animals that may be acting strangely. Always remember that stray dogs or cats are someone's pet and must be treated in this way. Any person reporting in good faith of animal abuse under 34-B 1901 shall remain confidential.

Dear Friends:

I am deeply honored to serve the people of Maine in the U.S. Senate, and I welcome this opportunity to share some of the areas I have been working on over the past year.

The ongoing COVID-19 pandemic continues to pose enormous challenges for our state and our country. When the pandemic began, I co-authored the Paycheck Protection Program that helped small businesses remain afloat and keep their employees paid. In Maine, our small businesses received more than 47,000 forgivable loans totaling \$3.2 billion. I also led efforts to provide relief for loggers, lobstermen, and bus companies.

In addition, I helped secure \$700 million to assist Maine's overwhelmed hospitals and nursing homes, and a new law I led prevented Medicare payment cuts to help further ease the financial strain on our hospitals. I also urged the CDC to update its recommendations so that our students and teachers could safely return to their classrooms, and I pressed the Administration to end the closure of the U.S.-Canada border.

While addressing the pandemic has been a major focus, I've also worked hard to ensure Maine's other needs are met. A group of 10 Senators, of which I was a part, negotiated the landmark bipartisan infrastructure bill that was signed into law in November. I co-authored the section of the bill that will provide Maine with as much as \$300 million to expand high-speed internet in rural and underserved areas.

Soaring inflation is another crisis, particularly when it comes to the cost of heating oil. I have strongly supported federal programs that help Maine families stay warm. In November, Maine was awarded \$35 million to help low-income Mainers pay their energy bills. And the bipartisan infrastructure bill included \$3.5 billion to help families make energy efficiency improvements that would permanently lower their heating costs.

As a senior member of the Appropriations Committee, I have supported investments in Maine's communities. This year's funding bills include \$265 million I championed for 106 projects across Maine. These projects would help create jobs, improve workforce training, address the opioid crisis, and increase access to childcare and health care services. In addition, I worked to reverse proposed cuts to our Navy in order to help protect America and keep the skilled workers at Bath Iron Works on the job. The bills also include \$475 million for the construction of a new dry dock at Maine's Portsmouth Naval Shipyard that will allow the Navy to continue to carry out its submarine missions. I will keep working to get these important bills enacted.

No one works harder than the people of Maine, and this year I honored that work ethic when I cast my 8,000th consecutive vote, becoming the only Senator in history to do so without ever having missed a roll call vote. The Lugar Center at Georgetown University once again ranked me as the most bipartisan Senator for the eighth year in a row.

In the New Year, I will keep working to solve problems and make life better for the people of Maine and America. May 2022 be a happy, healthy, and successful one for you, your family, and our state.



The incredible rollout of several effective, FDA approved COVID-19 vaccines helped reduce the risks of this deadly pandemic – but vaccine hesitancy, combined with the dangers of new variants, have prolonged this crisis and created new risks for Maine people. The challenges raised tension levels to boiling points during the fallout of the 2020 presidential election and the January 6th Capitol attack. But despite that, Congress was able to deliver for a nation gripped by an unprecedented pandemic. As we reflect back on the year, we see the important action that will make a difference for Maine people – as well as work still unfinished.

As COVID-19 continued to impact communities across our state and the country, Congress's first priority this year was to confront the pandemic's health threats and economic toll. We immediately got to work on the *American Rescue Plan*, crafting an emergency bill to meet the moment and get our nation back on stable footing. The legislation delivered essential support to businesses facing crises, households in need, and the medical professionals on the front lines of this fight. The funds helped get vaccine shots in arms, while also confronting the damage done to our economy. All told, the *American Rescue Plan* is bringing billions of dollars to Maine, helping the state continue to push through this crisis and bounce back stronger than ever.

The historic investments in the bipartisan infrastructure bill, combined with additional funding I pushed for in *the American Rescue Plan*, will bring an estimated \$400 million for broadband home to Maine. These funds will be nothing short of transformational, creating new opportunities across our state.

These two bills have made and will continue to make a real difference for Maine people, helping to both address the challenges of COVID-19 and lay a foundation for long-term success. I am proud of what we've accomplished this year – but I know there is still a lot of work to do and that the road ahead is challenging. Even still, I am filled with optimism because I know the true nature of our citizens, though challenged, has not changed. Despite every hardship, people in towns and communities have stepped up with strong local leadership, a willingness to help, and a Maine 'neighborhood' spirit. It is why I truly believe we can and will get through anything together. Mary and I wish you a happy, healthy, and safe 2022.

Dear Friends,

I hope this letter finds you safe and well. It remains a privilege to represent you in Congress, and I appreciate the opportunity to update you on what I have been working on for the people of the Second Congressional District.

This year, our small businesses, workers and families, hospitals, states, and towns continued to face challenges related to the coronavirus pandemic. COVID-19 has been a serious threat to public health and our economy that requires a comprehensive, ongoing response. While we are not yet out of the woods, there is a light at the end of the tunnel. Still, I know there are many Mainers who will continue to need assistance getting through this pandemic. I am committed to making sure our communities' most urgent needs are met to get our economy back on track.

One thing I am particularly proud of this year is that Democrats, Republicans, and the Biden Administration worked together to pass the bipartisan *Infrastructure Investment and Jobs Act*, which will make a once-in-a-generation investment in our nation's infrastructure and support Maine jobs. For one, shipbuilders at Bath Iron Works are a vital part of our economy, and the ships they build are critical to our national security. Throughout 2021, I led the Maine congressional delegation in pushing back against the Biden Administration's proposed decrease in DDG-51 shipbuilding, a proposal that would have had serious consequences for the shipbuilding workforce at BIW, one of the two shipyards that produces these destroyers, and American naval capabilities around the world. We fought successfully to include authorization for construction of three new DDG-51 destroyers in the final National Defense Authorization Act. I will continue to work hard with my colleagues on the House Armed Services Committee to ensure that we protect our national security and shipbuilding jobs in Maine.

My most meaningful work in Congress continues to be providing direct assistance to Mainers. My staff and I stand ready to serve you. 

Independent Auditors' Report

OPINIONS

We have audited the accompanying financial statements of the governmental activities, each major fund, and the aggregate remaining fund information of Town of Kenduskeag, Maine, as of and for the year ended December 31, 2021, and the related notes to the financial statements, which collectively comprise the Town of Kenduskeag, Maine's basic financial statements as listed in the table of contents.

In our opinion, the financial statements referred to above present fairly, in all material respects, the respective financial position of the governmental activities, each major fund, and the aggregate remaining fund information of the Town of Kenduskeag, Maine, as of December 31, 2021, and the respective changes in financial position for the year then ended in accordance with accounting principles generally accepted in the United States of America.

BASIS FOR OPINIONS

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Town of Kenduskeag, Maine, and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinions.

RESPONSIBILITIES OF MANAGEMENT FOR THE FINANCIAL STATEMENTS

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation and maintenance of internal control relevant to preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

Our audit was conducted for the purpose of forming opinions on the financial statements that collectively comprise the Town of Kenduskeag, Maine's basic financial statements. The combining nonmajor fund financial statements, schedule of property valuation, assessments, and appropriations, schedule of taxes receivable and schedule of departmental operations are presented for purposes of additional analysis and are not a required part of the basic financial statements. Such information is the responsibility of management and was derived from and related directly to the underlying accounting and other records used to prepare the basic financial statements. The information has been subjected to the auditing procedures applied in the audit of the basic financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the basic financial statements or the basic financial statements themselves, and other additional procedures in accordance with auditing standards generally accepted in the United States of America. In our opinion, the combining nonmajor financial statements, schedule of property valuation, assessments, and appropriations, schedule of taxes receivable and schedule of departmental operations are fairly stated, in all material respects, in relation to the basic financial statements as a whole.

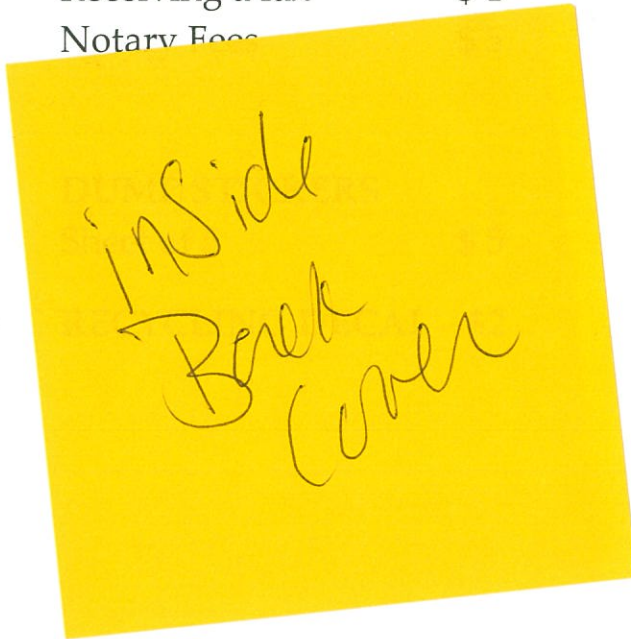
